

Donor Privacy Policy

1. Introduction

Thank you for considering making a donation to Atlanta Wealth Building Initiative ("we," "us," or "our"). We are committed to protecting your privacy and ensuring the confidentiality of your personal and financial information. This Donor Privacy Policy outlines how we collect, use, store, and protect the information you provide to us when you make a donation. 2. Information We Collect

- Legal Compliance: We may disclose your information in response to a legal request or as required to comply with applicable laws, regulations, or court orders.
- Financial Auditors: We may disclose your information in support of our annual audit.

We take reasonable and appropriate measures to protect your personal information from unauthorized access, loss, or misuse. We use secure payment processing systems and encryption technologies to safeguard your financial data.
